The Reason Why...

A while back, a fellow member of the Humboldt Genealogical Society mentioned a small private graveyard located near Route 299 in Blue Lake, Humboldt County, California. Janice, a native of Blue Lake, remembered the graveyard and knew one of the members of the family that were caretakers of it. I was intrigued! I ran into Janice at the Humboldt Room in the Humboldt County Library where she was researching some of the names of the people buried in the cemetery and I asked her for a copy of the map she had obtained. Janice told me that the family got together on Memorial Day to do a "spring cleaning" of the cemetery and afterwards it would be a good time to visit the graves.

Memorial Day came before we knew it and we set a date with Betty Swanson to visit it. The weather was threatening that day, but we donned our raingear and huddled under our umbrellas and trekked up the steep hill to the beautiful cemetery set up on Liscom hill. It rained the whole time we were there, but we took pictures and made our notes in spite of the weather.

We began with a copy of an old map of the cemetery that was made about 1918, with notes that had been added at a later date by members of the family. An attempt to identify some of the unmarked graves had been made in the late 1950's, but many were still unknown. Armed with this map, Janice and I set to work to find as many records and obituaries regarding the cemetery and the people buried there, as we could.

Thanks to the collection of Susie Baker Fountain and the Blue Lake newspaper, *The Advocate*, a great deal of information was found on the Norton's, Scott's and Swanson's, who are buried at the cemetery.

We were also able to identify some more of the people buried at Scottsville Cemetery that had not been previously listed on the map. However, their exact location cannot be ascertained. **In addition, we were able to correct some of the death and birth dates that had been on the map as well as on the current headstones and attempted to shed some light on who was really buried in the area that was marked "soldiers and children" on the map.**

Janice spent a great deal of time at the Blue Lake Museum going through microfilm of the Blue Lake Newspaper and we made many visits to the Humboldt Room and periodicals room at the library. The pages that follow contain some of the history of Blue Lake and Hoopa Valley as well as the memorials to the people buried in Scottsville Cemetery.

Scottsville Cemetery

Scottsville Cemetery is located on the northern outskirts of the town of Blue Lake; once part of the former town of Scottsville, the cemetery has a lovely view of the Mad River valley. It is small family cemetery containing over 20 marked graves and eleven and possibly more unmarked graves. In recent years it is lovingly kept up by the Swanson family, who has many ancestors buried there.

The first verifiable burial, in 1874¹, is of Nancy (Hanks) Scott, wife of pioneer William Marshall Scott, for whom the town of Scottsville was named. It wasn't till 1885 that we have the next recorded burials of Davie Maddux and Capt. L.P. Lupton. In 1888 there begins a spate of burials, nearly one every year, until 1902. After that point the burials are sporadic, the most recent being in 2003.

In 1888, Alice Norton was buried in the cemetery; she may have been the first of the pioneer Almonzo Norton family to be buried there. Alice and two of her brothers, George and Ozro, who all had contracted tuberculosis, were buried over a period of years at the Scottsville cemetery along with other members of the Norton family and their extended families. The cemetery was often referred to as the "Norton Cemetery" because of the many Norton family burials there.

One of Almonzo's daughters, Lucy, married Peter Swanson, and their child, Elwood, was buried in the cemetery in 1890. Later another son, Oscar, followed by his father Peter, Peter's brother John and later Lucy were buried in the cemetery. The descendants of this family have taken over the caretaking of the cemetery and in recent years it has been mostly Swanson descendants that have been buried there.

Many graves in the cemetery are now unmarked; whether it is due to deterioration or vandalism. Some on the Norton family graves have been remarked but many have not. A sketch of the graveyard was done around 1918 and later family members included as many names and dates as they could remember. We have verified and sometimes corrected the dates, by researching death abstracts and newspapers containing the death notices or obituaries of the deceased.

The most interesting part of the cemetery is an unmarked section that is now covered with brush. Family tradition has that this section contains 32-36 graves that included soldiers killed during the Indian Wars of 1862-1863 and babies of settlers passing through the area. There had been at one time a carved wooden marker commemorating the children buried there.

In trying to identify soldiers that might possibly have been buried there, I researched the Susie Baker Fountain papers, Marilyn Milota's "Obituaries of Humboldt County, California 1854-1899" and A.J. Bledsoe's book, "Indian Wars of the Pacific Northwest." The first dilemma is whether or not the term "soldier" refers to the regular U.S. Army or to the volunteer battalions gotten up during different periods from 1855-1864. Most casualties for the regular army occurred in the Eel River area. The California Battalion of Mountaineers, raised in 1863 and mustered out in 1864, suffered about 12 casualties over

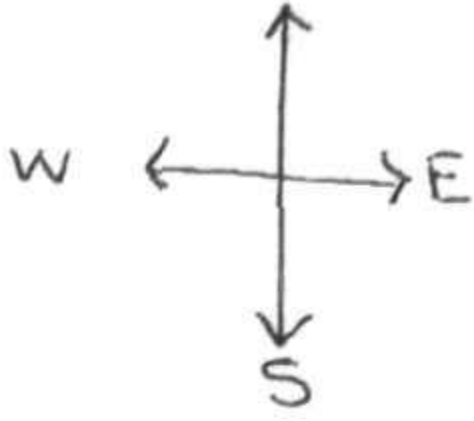
all, four of which were in the Mad River area. Whether or not these volunteers were buried in the area of the Scottsville cemetery or taken to Fort Gaston or Fort Humboldt is speculation. The records that cover this period are scattered over several different departments of the National Archives and it is a situation where we need to know the names of those killed to find out where they were buried. We do know that Lt. Lupton² who was a soldier in Colorado, and a Charles Johnson who was a Volunteer in the Mountain Battalion were buried in Scottsville in the 1880's.

Among the other possible people that could be buried in the unknown section of Scottsville Cemetery, there are several settlers that were killed near Mad River during that time period that cannot be accounted for in other cemeteries. There could also be Indians killed during that time period buried there. A group of names have been included in the description of this plot as possible people that may be or have been buried at Scottsville Cemetery.

For those whom we do know are buried at Scottsville Cemetery, we have recorded their passing, so that they too will not become among the "unknown."

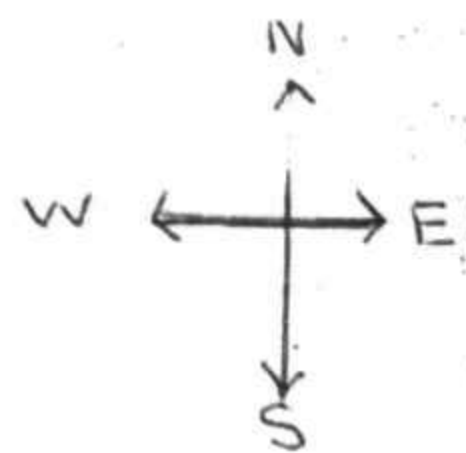

OLD NORTON CEMETERY DEEDED TO LOCAL VFW BY LAURADALE SWANSON

The old Norton Cemetery, on the hillside overlooking the valley of Blue Lake, including one and two-thirds acres of land, has been deeded by Mrs. Lauradale Swanson to the blue Lake Post of the Veterans of Foreign Wars, with the provision that they will clean it up and maintain it in good order.

Mrs. Swanson state their agreement calls for grading, landscaping, the erection of a plaque honoring all Blue Lake soldiers and the construction of a Memorial Building, and continuous maintenance. It is believed this will become a National Cemetery.

Every effort will be made to identify the graves already there, believed to be perhaps about 75 in all.

The transfer of the deed to the VFW did not take place since they were unable to identify the veterans that were possibly buried there.

Guy M. aka Arthur Almonzo Chase

Son of Arthur G.M. Chase and Mary Ann (Norton). He was born 18 February, 1890 and died 22 January, 1909.

DIED NEAR GLENDALE

Guy M., son of Arthur Chase, died at 6 o'clock yesterday morning at the home of his father near the Glendale school house. Deceased, who was 19 years of age was born near Blue Lake and had long been a sufferer from tuberculosis of the lungs and stomach.

The funeral will probably be held at Blue Lake Sunday, but at what hour we were unable to learn.

DEATH OF ARTHUR CHASE

Early Friday morning, January 22d, Arthur Almonzo Chase, the 19 year old son of Mr. and Mrs. A.G.M. Chase of Glendale, passed away there from the effects of tuberculosis of the lungs and stomach. The young man was born and reared near Blue Lake and was well liked by all who knew him. The funeral took place Sunday afternoon from the family residence and the remains were laid to rest in the Scottsville cemetery, Rev. Mr. Stanley, of the Blue Lake M.E. Church, officiating.

Mary Ann (Norton) Chase

Daughter of Almonzo and Lawra Lindsay Norton, married Arthur Guy M. Chase on 6 September, 1884 in Blue Lake. She was born 19 March, 1858 at Weitchpec and died 23 August, 1938

Mrs. Mary Chase, a native of Blue Lake, died at her home in Hoopa. She was 69 years of age.

She leaves two daughters; Mrs. Alice Bybarisus of Hoopa and Mrs. Vivian Wilder of Mexico and two sons, Ernest Chase of Hoopa and Irving Chase of Orleans. She also leaves three grandchildren and two great-grandchildren.

Services were held Thursday at 3:30 p.m. with graveside rites in the Scottsville cemetery at Blue Lake. The Rev. Henry Gill officiated. Services were under the direction of Black funeral chapel.

Arthur Guy "Chasie" Chase

He was the husband of Mary Ann (Norton) Chase, born 17 Jun, 1860 in Kennebec Co., Maine and died near Bald Mountain on 7 June, 1909.

GLENDALE RANCHER FOUND DEAD ON ROAD

The return of to Glendale of his team of horses with nothing but the head stalls on night before last, caused a searching party to go out after Guy Chase, a Glendale rancher, who left there last Thursday en route to Hoopa to join his family who are rustivating there, and resulted in finding the dead body of the missing man. The body was found in a canyon about 200 yards from an old unused road know as the old Lost Prairie road, about a mile and a half beyond the Bald Mountain house.

A broken pole on the wagon indicated that there had been a runaway, but the man had not been instantly killed, for he had made his bed near the wagon and had removed the harness from the horses, which he had then tied to the wagon. Blood stains about the bed and leading down to the water in the canyon led to the discovery of the body, which had been dead for several days. From this it is believed that Chase, after attending to the team, had crawled down to get water, but had not the strength to get back and had died there. The horses becoming hungry had evidently broken away and started for home, where their arrival caused alarm as to the fate of their owner.

These meager details were the only ones obtainable today. Deputy Coroner Dolson of Arcata left this morning for the scene of the probable incident and had arranged to hold the inquest on the spot.

Deceased was an old time rancher of the Glendale section and leaves a wife and several children. He was a native of Maine, aged about 50 years.

INQUEST HELD IN THE CHASE CASE

The remains of Fred (Arthur) Chase the missing rancher of Hoopa, whose body was found near the Bald Mountain House, were brought to Blue Lake yesterday and interred there last evening. As stated last evening Chase had been missing since last Thursday, at which time he had left Korbek with a team load of supplies for his home at Hoopa. When he failed to arrive at his home, his son came over to Hoopa to look for him and about that time the finding of his horses on the Lupton place two miles from Bald Mountain House indicated that some accident had occurred. A searching party, composed of Ad Moore, J.J. Underwood, Chas. Blake and a Mr. Willmer of Blue Lake, who followed, soon solved the mystery by finding the body of the man yesterday.

Deputy Coroner Dolson of Arcata was notified and going out to the place secured the body, held an inquest at the Bald Mountain House yesterday and arrived at Blue Lake last evening where the remains were interred as owing to their condition it was impossible to keep them longer above ground. From the testimony at the inquest the following narrative is gleaned:

Chase came to Blue Lake early last week from Hoopa and had been drinking there quite heavily and when he left there last Thursday with his rig to return to Hoopa was very drunk. He was last reported from Bald Mountain House on the homeward road, when he passed at 5 p.m. Thursday and was observed to be still very drunk. Later developments

showed that about 2 ½ miles beyond there the team turned into an old tan bark road to the left and after going some distance down it Chase endeavored to turn his team about, driving off into the brush at the side of the road to make the turn. In doing this, however, the pole, a pine stick, came in contact with a small oak and was snapped off at the hounds.

Chase had then unhitched and unharnessed the team and put on their halters but in doing this, before he could tie them, he had evidently fallen beneath the horse's feet and been trampled upon by the horses, the animals then wandering away. Chase had next taken his bed from the wagon and spread it on the road and laid down on it as shown by the blood saturated pillow and coverings. Evidently he became delirious and got up proceeding about 100 yards away where he laid down again at this point he left his vest and shoes and later started out again, going another hundred yards or so and lying down again. From here he made another move and had struck out through the thick brush down a steep declivity at the foot of which he had laid down and died.

When found the face of the body was unrecognizable by reason of being fly blown, the insects having been attracted by the blood on it, and decomposition there was already well advanced. The condition of other parts of the body, however, indicated that the man had not been dead over 48 hours. An examination showed that there were several very ugly cuts on the head which had the appearance of having been made by horses' hoofs, although the skull was not fractured. Taking these facts into consideration the jury returned a verdict of death from alcoholism and exposure. There is no suspicion of foul play.

DIES ALONE IN MOUNTAINS

One of the most mysterious deaths before the notice of the authorities of northern Humboldt is that of Guy Elmer Chase, whose body was found in a gulch bordering the Lost Prairie road about two miles beyond Bald Mountain, by a party led by Charles Blake of Blue Lake, on Wednesday morning of this week.

Chase, who is well known in the northern portion of this county was in Blue Lake last week to secure provisions to take back with him to his home at Hoopa, and as was his failing when in on this mission, had been drinking heavily, and was in a bad condition when he left Blue Lake Thursday of last week for his mountain home. Nothing more was thought of the deceased man until last Monday when one of his sons, accompanied by his cousin, by the name of Norton, came from Hoopa to look for the missing man and only succeeded in locating the horses at Lost Prairie.

The news of the find and the mysterious circumstances surrounding the case was quickly spread and on Tuesday a crew of men at work on the road discovered the wagon on a side road about 2 miles from Bald Mountain, but failed to make a report of their discovery. It was only on the following day that the body was found and the real facts of the matter brought to light, when the body was located in a precipitous gulch by Charles Blake, who led a party of Blue Lakers, who had gone in quest of the missing man.

From the appearance of the disfigured countenance and the bloody blankets discovered, as well as the location of the wagon it appears that after passing Bald Mountain, he in some manner turned out on the old discarded road leading to Lost Prairie and after he had proceeded as far as possible, attempted to turn his team around and return to the main road. The wagon tongue was broken in the attempt and from the evidence at hand, it would appear that he had gotten down and unhitched the horses as the harness was off and each had a halter on when discovered. It was probably at this time or even later that he received the marks of violence in evidence at the time of discovery, as it would appear that he was either kicked or trampled upon by the horses.

He then spread his bed upon the ground, as the blood saturated pillow and bedding had given silent testimony. It is generally conceded that from the loss of blood in his depraved condition, he became delirious and attempted to reach water, falling many times

in his attempt, and finally was so completely exhausted that he perished in the gloomy wilderness.

Deputy Coroner Dolson, who was notified, summoned a jury at Bald Mountain, which after hearing the testimony brought a verdict of death from alcoholism and exposure as there could be found no suspicion of foul play. The body, with the exception of the face, was at the time of its finding in a good state of preservation, but the countenance was so badly decomposed that the remains were interred at Blue Lake the same evening. Chase left a wife and several small children.

MET DEATH BY A LONELY TRAIL

A.G.M. Chase Died Near Bald Mountain

Days of Anguish In Solitude

Wagon Found by Workmen, and then the Mangled Body—Secret Dies With Him

While driving from Blue Lake to Hoopa, A.G.M. Chase, an old resident of Humboldt county, met his death sometime between his departure from this place on Thursday of last week and the following Tuesday, at which time his body was found near the Lost Prairie trail, beyond Bald Mountain.

The unfortunate man was last seen passing the Bald Mountain house at about 5 o'clock on Thursday afternoon, and though it was known that he had been drinking heavily, on doubt of his safety had been entertained and the discovery of his wagon by men working on the county road lead to a search for the missing man. A telephone call was sent to Blue Lake, and in response a party composed of J. A. Moore, Constable James Underwood, Chas. Blake and H.A. Willmer went on Wednesday to the scene, where they were met by others who had arrived by that time, and after a time the body was located. The horses were found in the vicinity.

The Lost Prairie road is a blind road leading to the left of the county highway about two and one-half miles from Bald mountain. It was on this trail, a half mile distant from the county road, that the wagon and horses were found. The horses had been unharnessed and turned loose, and the wagon tongue was broken. Near the wagon were found the man's bedding, which was soaked with blood, with little pools of blood on the ground about the bed. At about 100 yards down the road was found another place where the man had lain, and again some distance along the road still another resting place. Finally, some 150 yards below the road in a thicket of brush, the dead man was found half dressed, without shoes or hat, and with badly lacerated face and head. Papers from the dead man's pockets were found along the course leading to his body, and in his pocket nothing was found except a match safe.

Except for mechanical injuries the body was in good condition, and probably life had not been extinct longer than 48 hours when the body was found Tuesday.

Deputy Coroner J.G. Dolson and party being notified, reached the scene on Wednesday and rendered a verdict of death from exhaustion through the following causes, alcoholism, exposure, and injuries from being thrown from a wagon. The coroner's jury was composed of Cornelius Dickson, Robt. McGahey, George Scullion, Herbert Reid, Elmer Gastman and Harry Cole.

After the inquest the body was brought to Blue Lake and interred Wednesday evening in the Scottsville Cemetery.

Deceased was a native of Maine, aged 49 years, and for many years a resident of this county. A widow and three children—two sons and a daughter—survive him, all residents of Hoopa.

The motive for driving out of the traveled road into an obscure trail is one that can hardly be explained, though it is said that the horses driven had at one time been pastured in the vicinity and may have led off in that matter of themselves. The man no doubt been led to wander from the team and wagon in search of water, and the findings in the case indicate he must have endured several days of intense suffering before death finally came to his relief. How the deceased found his way with team and wagon into a solitary place

in the woods, and the exact circumstances attending his death are features of the case which no doubt will remain conjectural.

Flora Elizabeth Chase (Mrs. Ralph Ottley)

Daughter of Arthur G.M. and Mary A. (Norton) Chase. Born 20 June, 1891 at Hoopa and according to death records died 9 July, 1918. Family map has death date as 1917.

Mrs. Ralph Ottley, nee Flora Chase of Hoopa Valley passed away last Tuesday evening while camping on the Bald Hills, near the Willis Norton ranch. The lady had been ill for some time past, suffering from tuberculosis, and her death was not unexpected. She was a native of Blue Lake, aged 27 years, and besides her husband she leaves to mourn her untimely death, her mother, Mrs. Mary Chase and two sisters, Mrs. Ben Wilder and Miss Alice Chase and two brothers, Ernest Chase and Urban Chase all of Hoopa valley. The funeral services were held at Hoopa Wednesday evening, Rev. Wm. Baesler officiating and the remains were brought down here that night in Abner Douglas' auto truck, accompanied by the husband and her sister, Mrs. Ben Wilder. They were laid to rest in the Norton cemetery near here, beside those of her father and brother.

Alice Norton

Daughter of Sherman and Leah May Norton, she was born August of 1898 at Glendale and died of ptomaine poisoning on 30 March of 1902. She was 3 years and 7 months old.

Hugh Norton

Son of Sherman and Leah May Norton, he was born 15 August, 1899 at Glendale and died 16 August, 1899 at the age of 1 day old.

Bobby

Elwood Theodore (Ted) Swanson

He was born 8 November, 1926 and died 15 April, 1992.

ELWOOD THEODORE "TED" SWANSON

Elwood Theodore "Ted" Swanson died April 15, 1992, in Arcata at age 65. A native of Glendale, he was a resident of Blue Lake.

Mr. Swanson was a native of Humboldt County and attended school in Hoopa and other local schools. He went to work in the woods at an early age and retired from Arcata Redwood at age 55.

Mr. Swanson was an active member of the Blue Lake Fire Department and the Blue Lake Veterans of Foreign Wars Post No. 2481. He was an avid fisherman and hunter and loved the outdoors. He loved life best when he was helping others and working with his hands in his garden and making things with wood. But his greatest love in life was his family; his wife, children and grandchildren. He will be missed by all who knew him.

He is survived by his wife, Eleanor Swanson of Blue Lake; his mother, Lauradale M. Swanson of Redding; his daughter and her husband, Kathy and Robert Hook of Eureka; his son and his wife, David and Lori Swanson of Eureka; two granddaughters, Kristin Hook and Nancy Swanson of Eureka; and two grandsons, Wade Swanson and Steven Swanson of Eureka. He is also survived by three sisters and their husbands, Audrey and Joe Mello and Jean and Jack Snider, all of Willow Creek, and Arlene and Orvis Box of Blue Lake; two brothers and their wives, Leslie and Frieda Swanson of Redding and Oscar and Jan Swanson of Healdsburg; and numerous nieces, nephews and cousins.

He was preceded in death by two brothers, Don Swanson and Eddie Ray Swanson; and a sister, Ruby Swanson.

Friends are invited to attend funeral services Saturday, April 18, 1992, at 10 a.m. at Paul's Chapel, Arcata, with James Brown officiating.

Eddy Norton

There is a dilemma as to which Eddy Norton is buried in this plot. There are three Ed Nortons in the death records:

Edward Norton born 1871 in Eureka & died about June 27 or 28, 1900 in Prescott, Arizona or his son Edwin Norton. Our deduction from the obituaries is that both are buried in the same general area.

DIED IN ARIZONA

Sherman Norton received this week the sad intelligence of the death of his brother, Edward Norton, at Phoenix, Arizona, which occurred a few days ago. Deceased had been in poor health for some time past suffering from consumption, and it was only four or five weeks ago when he and his young brother Oscar went to Arizona for the benefit of his health, but all efforts to that end failed and the dread disease finally claimed him. Eddy Norton was a native of this county, aged about 35 years. His body will be brought here for burial.

DEATH OF EDWARD NORTON

Edward Norton, formerly of Phoenix, died at the Mercy hospital, in Prescott, of consumption a day or two ago. He was 28 years old and leaves one child. His brother, Oscar Norton, of Phoenix took the remains to California for burial.

Word came on Tuesday from Phoenix that Ed Norton, formerly of Blue Lake was dead, and the body would be shipped immediately. The same will probably arrive on next Tuesday.

Edwin Norton, son of Edward and Josephine (Bussell) Norton, who died 4 September, 1915, in San Francisco, after a neck operation.

Edwin Norton remained in Arizona after the death of his father attending the Sacaton Indian School. In 1907, at the age of 12 years old, his uncle, Sherman Norton, brought him back to Humboldt county to be raised by them. Ed, however, became entangled with the law, and was committed to the Preston Reform School as incorrigible; escaping once and "terrorizing the Reservation Indians" at Weitchpec before he died during an operation in San Francisco.

Deceased was a genial, kind hearted and loyal citizen, honest and upright, square in his dealings with his fellow men, and had as many friends as he had acquaintances. WILLIAM SCOTT DEAD

A Lingering Illness from a Complication of Maladies—The Funeral

Mr. William M. Scott, an old pioneer of Humboldt county, died at his residence in Scottsville, a suburb of Blue Lake, at an early hour last Wednesday morning. Mr. Scott had been sick some weeks of a complication of diseases and while there was general belief that his recovery was a matter of doubt his demise was not expected so soon.

Deceased was an old resident of this county, he having come to Humboldt in the fall of 1853 and with exception of a visit or so to Kentucky has resided in the county continuously ever since. Mr. Scott accompanied Mr. James Kilzer to the county and for a time was engaged in the stock business for him on Kneeland prairie. Subsequently the two removed to Hoopa valley where Mr. Scott's companion built a flour mill and Mr. Scott himself took up a claim. When the government about 1867 set apart the Hoopa reservation there for the Indians the settlers in the valley were reimbursed for their improvements. Mr. Scott received quite a snug sum for the fences he had built and the buildings he constructed and with it he came to present site of Scottsville, and, having purchased a tract of land, built a house and opened a hotel.

He has been in the hotel business ever since and was known far and near as a kind-hearted, generous, whole-souled man from whose hospitable door no one was ever allowed to go away hungry or thirsty or tired. It has been said of him that he would discommode himself to accommodate a friend.

For a number of years the Scottsville hotel was the only hostelry in this section and had a big run, being the favorite stopping place of travelers to and from the mountains. There was also a store, which did a flourishing business. Deceased leaves a widow, Mrs. Sarah Scott, and five children, Benjamin, Oliver, Emma and Lizzie Scott and Mrs. Carrie David. He was a member of Bay City Lodge No. 111, A.O.U.W., and he carried an insurance in the society in the sum of \$2000. The funeral took place from the family residence Wednesday, the Rev. Mr. Baesler officiating, interment in Scottsville cemetery under the auspices of Advance lodge No. 273, A.O.U.W. The attendance was quite large, the order at the county seat being represented by Messrs. Fred W. Bell, John H. Gyselaar and Thomas Johnson, and Dr. O.J. Gates.

Map description reads: 36 graves, mostly soldiers, killed during the Indian War 1862-1863.

In reading through Bledsoe's book "Indian Wars of the Pacific Northwest," the Susie Baker Fountain Papers, the California Civil War Roster (for the California Mountaineer Battalions) and "Obituaries Humboldt County California 1854-1899," about seventeen men in the capacity of soldiers, volunteers, or guides for the army, were killed from 1861-1864. (This figure does not include civilians.) Of these seventeen, only four died in the area near Blue Lake.

However the following people were listed in the Death Records or the Susie Baker Fountain papers as being buried in Scottsville, they may or may not have been removed at some time:

SCOTTSVILLE

At the foot of Liscom Hill³, which is the northern boundary of present day Blue Lake, there once existed the town of Scottsville. It was founded in 1867 by William M. Scott. As Scott sold parcels to the town; the town grew and eventually merged with Blue Lake, a town founded by Clement Chartin, a French immigrant, who had purchased land to the south and towards the Mad River. In 1910, several years after the deaths of both men, Blue Lake would become an incorporated city and Scottsville would be only a memory. Scott and another prominent land owner, Almonzo Norton, were both buried in a private cemetery on a small plot of land on Liscom Hill, which was known as the Scottsville Cemetery. Just who were these two early pioneers?

WILLIAM MARSHALL SCOTT

William Marshall Scott was born in Kentucky in 1836⁴. In 1853, at the age of 17 he left his home with a man by the name of James Kleizer, traveling by ox drawn wagon westward to California. They first settled in the mountains above Eureka, which for a time was called Kleizer Prairie and later named Kneeland Prairie, where they were engaged in the stock business.

In 1855, both Scott and Kleizer, moved to the Hoopa valley, which was then part of Klamath County. Kleizer built a flour mill and Scott took up a claim and became a rancher. This was land not yet open for purchase by the federal government, therefore the claim of preemption, or commonly called "squatters' rights," was used by the settlers in this area. No actual deeds were filed. There he married Nancy Hank, a native of the area and their three children, Carrie, Benjamin and Oliver were born in Hoopa.

When the federal government established the Hoopa Indian Reservation around 1866, they reimbursed the settlers for the land and improvements. Scott received the sum of \$2,938.80⁵ and then purchased 160 acres at Mad River and commenced to establish Scottsville. There he built a hotel, which would serve travelers between Union (later Arcata) and the Hoopa valley and Trinity County to the east. (This route traveling through Scottsville eventually became the state highway until the freeway, built many years later, bypassed Blue Lake, traveling over the hill above).

³ Liscom Hill was the name given the entire range above present day Blue Lake. Today, the more familiar Liscom Hill Road begins from Glendale and up to the western side of the hill.

⁴ In the Susie Baker Fountain Papers, Volume 68 Pages 12 & 35, Scott's birth date is listed as 1820 and age of death 74. However, the abstract of death record Book 1-64 lists his age as 57 and the Federal census records tend to support this age.

Among the buildings erected by Scott were a livery stable, blacksmith shop, store, saloon, a separate home for his family, and a one room schoolhouse. He moved his family from Hoopa about 1872. Believing his children should learn to read and write, he assembled the required seven students, (including his own three) to qualify for a teacher, establishing the Scottsville School. Later, according to his son Benjamin, as the number of children increased, they attended a larger school over the hill at Powersville.

In 1871, Scott traveled to Kentucky, returning with his widowed mother, Elizabeth Scott. Three years later, his wife, Nancy, died at the age of 38. She was apparently one of the first to be buried in the Scottsville Cemetery. It is not known why this site was chosen. According to family legend, soldiers and children were buried there during the Indian wars of 1862-3, but no documentation to verify this story has been found. It may have been considered sacred ground.

A post office was established in Scottsville under the name Mad River and William Scott was appointed postmaster. The surrounding area was referred to as Mad River prior to Scott's establishing his settlement. This post office existed from 1872 to 1877. (In 1878 Clement Chartin was granted a post office in Blue Lake). Scott was elected constable of Mad River in 1871 and served in this capacity until 1880.

In 1876 he married Sarah Jane Kidd, daughter of another Kentuckian, James Allen Kidd, who had also settled in the Hoopa area. Two daughters, Emma May and Elizabeth "Lizzie" Belle were born of this marriage.

William's mother, Elizabeth Scott, died in 1891 at the age of 91, and was buried in the Scottsville cemetery.

Two years later, William Marshall Scott, was buried alongside his mother and first wife, Nancy. He was 57 years old. Only his daughter Carrie and her husband William F. Johnson were later buried in the Scottsville Cemetery.

The Scottsville Hotel was the first hotel built in the area. (Scott's obituary in the Blue Lake Advocate notes that it was for a number of years the favorite stopping place for travelers to and from the mountains) The Blue Lake Hotel, owned by Clement Chartin, became more of a destination resort for relaxing. William Scott seemed to be comfortable and accepting of the sometimes more rustic travelers. Several managers operated the hotel until he sold it in 1885 to Almonzo Norton and John Hooker. Hooker sold his portion to a French immigrant named Edmund La Conte. By 1888, Scott had built another hotel, (referred to as the Second Scottsville Hotel). He managed this himself, advertising in the *Advocate* the newly furnished hotel was a "quiet and homelike house".

William Scott died on the 20 June 1893. His wife, Sarah, then managed the hotel. On the same front page of the *Advocate* that reported the death of William, was also a large advertisement for the accommodations of Scottsville Hotel under the management of Mrs. Wm. M. Scott; proclaiming "Entertainment for Man and Beast".

For many years the children and grandchildren of William Scott and his wives, Nancy and Sarah, would remain in the area. But, without the guidance and personality of Scott, the town was destined to its eventual disappearance. Finally, with the building of the Arcata & Mad River railroad through Blue Lake, Blue Lake's dominance would prevail.

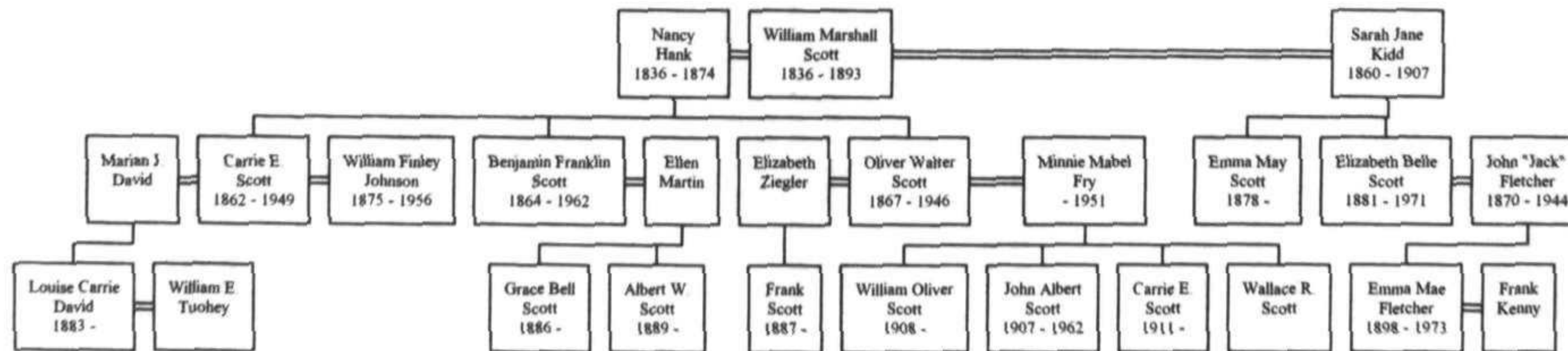

ALMONZO NORTON

Almonzo Norton was born in New York in 1833 to Zacharias and Amelia Thompson Norton. The children of the Norton's were: sons named Alphonzo, Lorenzo, Ozro, Arkinso, Almonzo, Loratio, Pizarro and Alonzo and daughters: Julia, Serena and Bythena. Zacharias, a farmer and miller, died in 1842. Almonzo was then eleven years old. At the age of fourteen Almonzo worked on a farm and later a sawmill, in Pennsylvania. Perhaps the gold fever struck him, for in 1852 he made his way from Pennsylvania to St. Joseph, Missouri, there; he outfitted a wagon and oxen for the six month journey to California.¹

In California, Norton first made his way to Placerville, where he mined for two years. Apparently, he made enough money to purchase thirty mules and became a packer, taking his first load from Shasta to the Salmon River. In 1858 he purchased land in the Hoopa valley and began ranching, where in 1859 Norton married Lawra Lindsey, a native of the valley.

When the federal government established the Hoopa Indian Reservation in 1865, Norton received \$5,728 for his land claim and improvements. He was also in partnership with Isaac Newkirk. This firm, Newkirk and Norton received \$13, 206 from the government for their property.² (This was probably a store and hotel, as Newkirk had operated a store in Arcata before going to Hoopa. Newkirk also advertised for the sale or lease of the Valley Hotel in 1858. Since Norton devoted his time to ranching, his partner managed the store and hotel.)

Norton then retired to his ranch on the north fork of Redwood Creek. In 1872, when he purchased land in Scottsville, he and his wife had seven children, Mary (Chase), Lucy (Swanson), Willis, Alice, Sherman, George and Edward or Edwin.

In 1874, he sold his ranch on Redwood Creek to Joseph Hooker for \$1250 and moved his family to Scottsville. There, three other children: Ozro, Ezra and Oscar were born.

After selling his ranch, he purchased 320 acres of land in the Glendale area, and acquired more land the next year, just west of Scottsville, by government patent. He then purchased another 160 acre claim north of William Scott's claim. Norton continued to add to his land, as well as selling off smaller parcels. At the time of his death he left an estate of 850 acres of land to his children.

Almonzo Norton was highly involved with his community both civically and as a business man. In 1873, Norton is listed as an official on the Mad River election board. He also, with William Scott and others, petitioned the county for a road from Lindsey Creek to Scottsville, which was at the fork of the trails to Hoopa and Trinity County.

In 1885 Norton purchased, with John Hooker, (who sold his interest to Edmond La Conte), the Scottsville Hotel, which La Conte managed for a time before selling out to Norton. After Almonzo's death, his son Sherman, moved the hotel and converted it into a private residence. The residence was destroyed by fire in 1903.

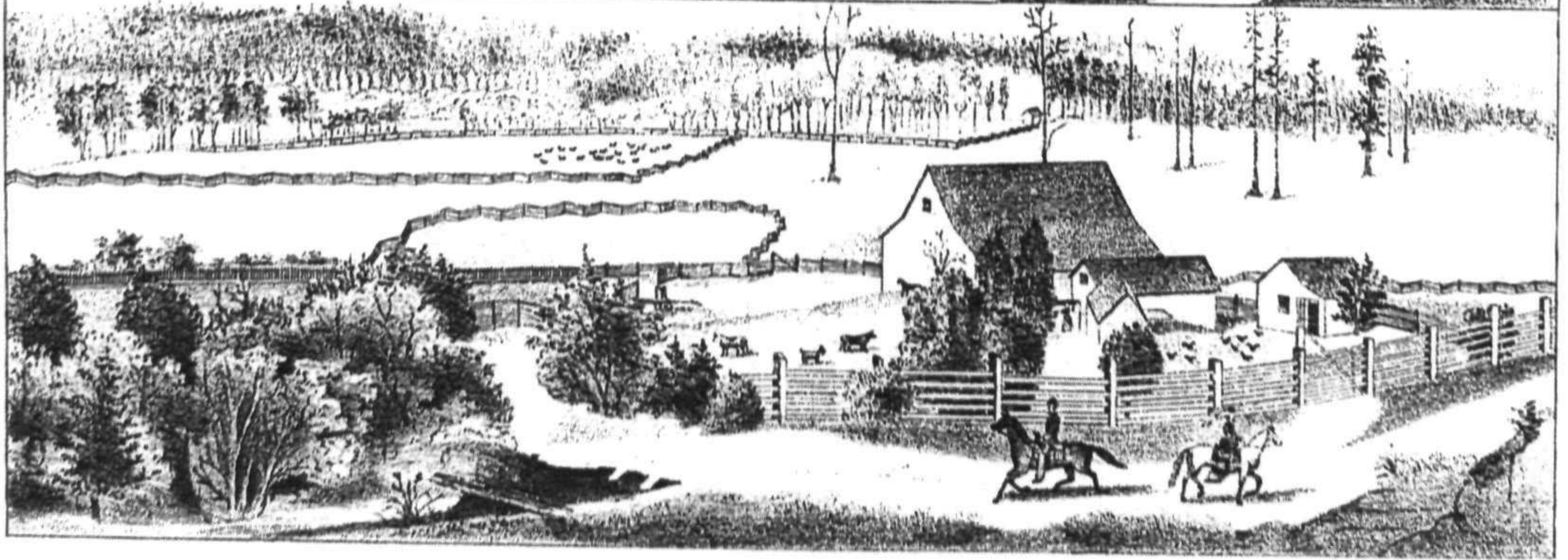
In 1891 he purchased, from William and Sarah Scott, the land which contained Scottsville Cemetery, where his wife, Lawra, was buried in 1889.

In 1892, when the Blue Lake Cemetery Association was incorporated, Almonzo Norton served as a director along with Clement Chartin, K. Geer, Samuel Baxter and Dr. Marvin.

Almonzo Norton was a well respected rancher and businessman. He died on 1 April 1898, and was buried in the Scottsville Cemetery. The land which contains the cemetery has remained with the descendents of his daughter, Lucy Norton Swanson, to the present day. The home that he built for his family, overlooking the valley, has also survived in tribute to his memory.

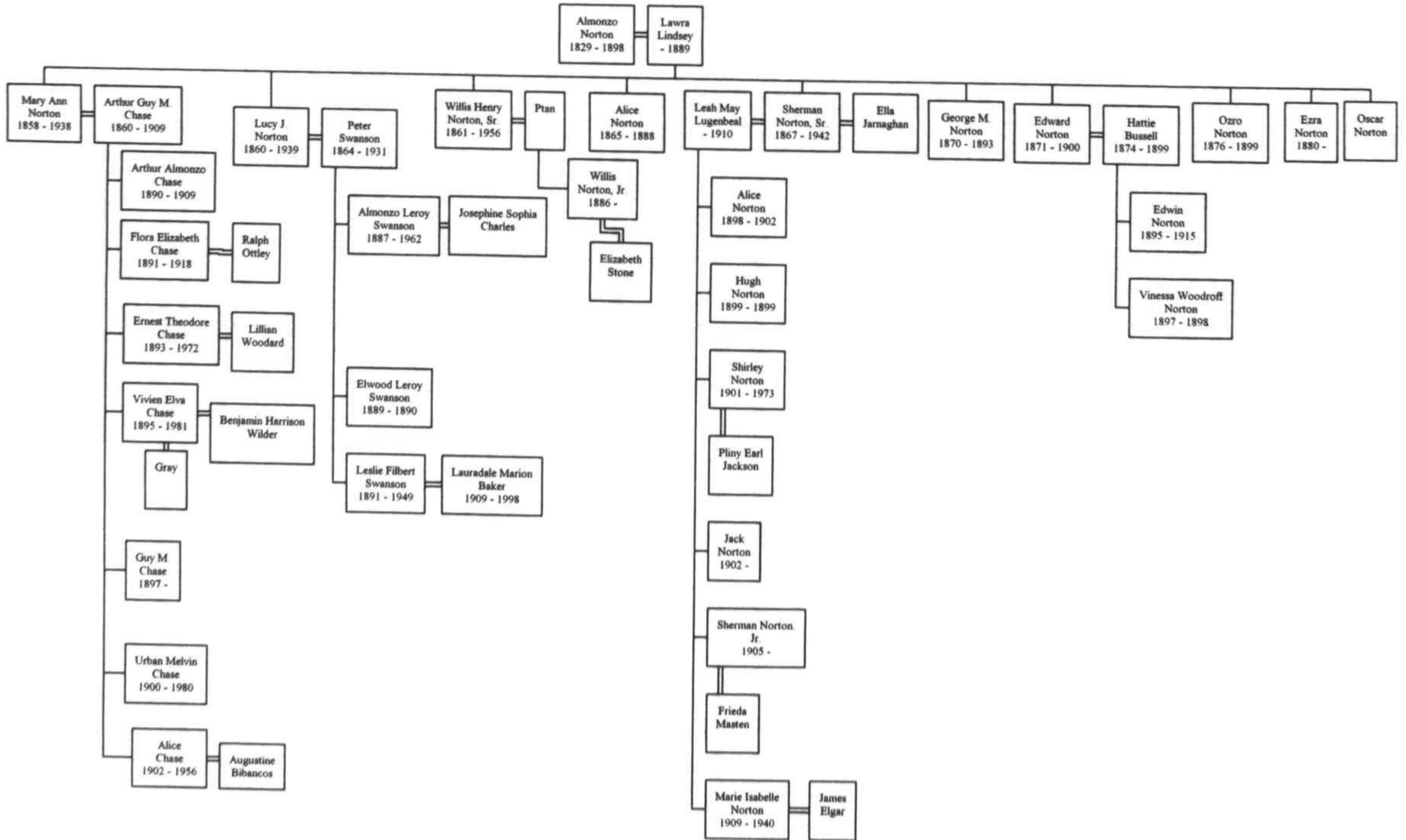


RESIDENCE OF A. NORTON, BLUE LAKE.
