The officers and members of our Society have given a great deal of time toward our meetings and workshops and our First Family group is growing.

"The Marriage Records of Siskiyou County from 1852 to 1910" have now been typed and are ready for publication.

On October 1, 1915, near Rio, Knox County, Illinois, a gray granite monument with a cannon mounted on the top, was unveiled. This monument stands by a small family burial plot, henoring the soldiers buried there. The inscription reads as follows: "Adam Bruner and Peter Bruner, soldiers of the Revolutionary War: J.K. Dickerson, Hanson Blake and Michael Young, soldiers of the Civil War."

This story is about Adam and Peter Bruner as the generations have passed the information on to me, and how these two brothers came to be buried in Illinois when it was still an unopened wilderness at the birth of our nation. Why they moved this far west we may never know.

Peter and Adam were brothers, sons of Michael Bruner. Their grand-father, Jacob, emigrated from Germany in 1728, to Frederick County, Maryland. Michael was born in 1729, the same year Jacob's father and brothers emigrated. The family moved on to Pennsylvania some time after 1785. Peter was born in 1760 and Adam in 1763. These four generations of Bruners became true Americans and when it became necessary to fight for their new-found freedom, the Bruners did so willingly. Michael had three sons enlist in American armies.

Peter served in the Lancaster County Militia sometime between 1770-1780, under George Feather's 3rd Company, 9th Battalion and in 1782 under Capt. Jon Muller's 6th Company, 8th Battalion.

Adam enlisted in Philadelphia in 1781 as a private under Capt. John Gayer's 3rd Regiment and served for four years.

Leonard served in Capt. Thomas Morton's Company of Westmoreland County, Pennsylvania Militia.

After the War, Michael's family moved to Franklin County, Virginia. The great western movement was starting in the new nation and the Bruners were right there too! Peter married Sarah Paynish and stayed in Virginia awhile and the rest of the family moved on to Jefferson County, Kentucky. Adam married Elizabeth Rice at Louisville in 1785. In 1786, the family moved further down the Ohio River to the wilderness county of Brecken-ridge, still in Kentucky. Here Adam raised his family of six sons and one daughter.

He was later joined by his brother Peter and in 1814, Peter and Adam's father Michael, died. He was buried there on Bruner's Ridge, Breckenridge County, where some of the Bruner descendants still live today. It was also there, in 1814, that Adam's son Michael married Peter's daughter, Elizabeth.

In 1825, the family again packed up and moved into the newly opened wilderness. They crossed the Ohio and up to Orange and Lawrence County, Indiana. By now the Bruner family was spreading over a large part of the new America; but there were to be still more moves.

In 1830, Michael's family left Indiana and ventured into Illinois, to Knox County, near Rio. Michael settled on Section 25, and with the other Bruners that came to Rio built a tavern, fort and later the Washington

Church. In 1840 or '42, Michael visited relatives still living in Indiana, returning home with his father and mother and his wife's father. Peter. Elizabeth Rice Bruner died in 1842, shortly after making her new home in Illinois, at the age of '6. And in 1846, her husband Adam, Revolutionary soldier, died at the age of 83. In 1850, Peter passed away at the age of 89. These men had lived full, hard lives, with a continual struggle for life itself and the hardships of a new land and a new country.

There is no way right now to list all the Bruner descendants of these two Revolutionary soldiers buried in that family plot in Illinois. For our Bicentennial project of bringing the genealogy from our Revolutionary War ancestor down to ourself. I have left out a great many Aunts, Uncles, Cousins, etc. But I did very much want to enclude cousins Alice and Harriette who have helped me very much on this line. So, on with more Bruners.

Michael Bruner, son of Adam and Elizabeth, was 45 years old when he moved his family to Knox County, Illinois. Michael and his wife Elizabeth Bruner, daughter of Peter and Sarah, became the parents of six children: Walter-1815; Sally-1817; Susan-1819; Harrison-1821; Eliza-1823 and Elijah-1825. Michael farmed and became prosperpous and a prominent man in the community. He lived forty years in Knox County and in 1870, he passed away and is buried in the family plot near Rio, where his wife, parents, two children and a number of grandchildren proceded him.

I don't know what became of Michael's oldest son, Walter. Harrison died in 1844, leaving a wife and a month old son. Sally, called Sarah, wife of D. Young, died in 1861. Elijah the youngest son, worked on Michael's farm. He and his wife, Polly, had three children before she died in 1853. He soon remarried and with his 2nd wife, Margaret, had five more children. Elijah and family stayed in Illinois as did Eliza.

Eliza married John R. Woolley in 1841 and in 1865 the last of their eleven children was born. In 1883, a daughter, Mary married John Weech. This family also raised their five children on Illinois soil. The oldest son, Richard B. Weech, married Anna Rose Cunningham in 1906. They raised a nice family of six: Parriette, Alice, John J., Anna Rose, Catherine and Irma. Alice Weech Cole, her daughter and grandchildren still live in Knox County. So Bruner blood has been in Illinois almost 150 years. But there was a wondering blood in the Bruners too.

Eliza's sister, Susan, called Susannah married Nicholas Dowell. Eight of their fourteen children are buried in the small cemetery with ancestors Peter and Adam. The family lived in Illinois until about 1868. Then Nicholas gave up his blacksmith business in Galesburg and took his wife and younger children, by wagon train to California. He homesteaded by Watsonville where Susannah and Nicholas lived out the rest of their lives. One of their married daughters, Anna Douglas, with her two children, followed her parents, by one of the first trains west. Later she married William T. Warren and they moved to Virginia City, Nevada. Later they homesteaded a ranch near Wabuska. Where their four children were born. Their daughter Etta was married at home to Harry Halliday. On the train trip to Los Angeles, they stopped in Bishop. Harry took up the blacksmith trade and they stayed the rest of their lives there. They had a good life and raised four children: Ellen, Ruth, Warren and my mother, Phyllis Halliday Skaggs and that brings it down to me.

EARLY SCHOOLS OF FORT JONES AND SCOTT VALLEY AREA compiled by IRENE JORDAN NELSON in 1959 and 1960. (It is noted that there are already changes in the following information.)

For some time I have been collecting data on the schools in this area. Part of my information on the Fort Jones Schools came from Gus Reichman only a few months before he passed away, while some was told to me by W. D. Mathews, Sr. about the same time in 1959. Several others helped with information; they will be mentioned later. Newspaper clippings have been used and part is from my own experience and memory. I have gone more into detail on the Fort Jones School as that is where I attended so am more familiar with them.

As everyone knows, the search for gold brought the first white people into this valley; agriculture also had its influence; soon the people began to settle in various spots as the families came to join the husbands and fathers. Schools were the natural follow-up.

In those early days the little schoolhouse was not only used for the education of the "young fry", it was also the gathering place for social and religious activities for all of the settlers.

The first schools in the valley were started in 1859.
There were three of them, the Washington or Crystal Creek District as it was more familiarly known, the Douglas District, and the Franklin District. In the 1950 issue of the Siskiyou Pioneer, there is an article by Ira Walker who says, quote:
"The first schoolhouse was built about one and a half mile north of the old Crystal Creek Church at what the oldtimers called the log corner:". This was at the northwest corner of the old Wilson Bros. Ranch, at the point where the road coming from Bryan Bridge via Corey Lane intersects the Yreka-Fort Jones, Oro Fino, Hayes Corners, and Rough and Ready road. (Hayes Corners was later Greenview and Rough and Ready later was Etna.) This log corner was marked for a number of years by a log fence enclosing the Wilson Bros. land.
The Washington or Crystal Creek District 1859:

The Washington or Crystal Creek Schoolhouse was a well-built structure with planed weatherboarding. Every board in the entire building was hand planed. The paneled doors, and window sashes, likewise were handmade. The exact date the school was erected is not known as part of the records are gone. The log Church was built in 1854. We found that the district voted funds in 1866 to move the building to another location, about one-half mile north, on the land owned by J. H. Walker and sons. This property is now owned by Frank and Joe Johnson. In 1878 another and very much larger school was built,

one-fourth mile West, out on the stage road. This new structure was two-stories. The hall above served as a community center. The social life of the valley centered around Crystal Creek Hall. The first lights used were tin, kerosene oil wall lamps hung aroundthe walls". Unquote. The Douglas District 1859:

This school was in the vicinity of Etna but all the inform-

ation I have is from a couple of old newspaper clippings.

Oct. 3, 1875. On Thursday evening of last week, the recently built and furnished schoolhouse in the Douglas District, Scott Valley, located between the farms of Josiah Doll and Thomas Timmons burned to the ground. How the fire started is a mystery as there had been no fire in the school that day, and although many saw the fire at a distance it was not known to be the schoolhouse until the children went to school the following day. The loss is estimated to be not much short of \$1,000 on the building and furniture,

Scott Valley News, Apr. 5, 1890. The Douglas School, C. E. Irons, teacher, will give an exhibition of the schoolhouse on Saturday night, April 29th, admission 50 and 25 cents; the proceeds to be applied to the purchase of furniture for the new

schoolhouse. A fine program is in preparation. The Franklin School 1859.

This school was located on the East side of the valley on a little rise shortly beyond the house where Ben Hurliman, Jr. now lives.

That school served until 1888. Nell Bryan Burton gave me the information for this school. In 1872, her brother Charlie Bryan started to school in the first grade. I. A. Reynolds was his teacher. Charles is probably the last of that generation who went to school at that location. Mr. Bryan was born in 1867 so is now 93 years of age. His older brother Jim Bryan also Ed. Varnum and August Fellwere among the ones attending school in that location. Some of the other teachers were; Narcissa Davidson, who later became a nun; George Rice, noted for his fine penmanship; George Tyler, Kate Arnold, who was a half-sister of Curly Bower; P. P. Peterson who had a violent temper; Dora Herd, who lived where Emmet Roberts does now. She later married Lord Little who came from England. They went to Kimberly, Africa to live, and Fannie Mathews who later mararied Jim Bryan.

By 1888 a new school was built on the James Bryan ranch. The first teacher there was a man named Pierce. Ed Nolan came in 1890 followed by Ben Healey in 1891-92 and he was Nell Bryan's first teacher. Other teachers there were: Stoney Mathews 1893-94, Frank Walker 1894-95/ (He was an uncle of the Mc Craary's.) Will Wilson 1895-96 who married Maude Paxton, and Pete

and Pete Luttrell 1896-97 who later became a successful doctor in San Francisco. Nell Bryan graduated under him. Mary Davidson 1897-98 who married James Walker, Frank Bills 1899-1900, Kate Dowling 1901-02, George Luttrell 1902-03, Elizabeth Walker 1904-05, Florence Manning 1906, who was a relative of the Lindsays, August Geney 1907, Pearl Hight and Harriet Cowan. The school finally was taken into the Etna district and the building was later made a part of the Malcolm Hayden home, at the same location.

The quartz Valley School 1860.

This school was built on a piece of ground deeded by Asa and Eliza Howard for educational purposed. This information is from The Siskiyou Pioneer 1955. Daily attendance depended on the distance to school, and weather conditions. Most children had five miles to walk. The only facilities were rough board benches. There were no shelves for books or slates. According to James Allen (who later became Superior Judge of Siskiyou County) he was graduated from Quartz Valley School in 1898. Some of the teachers were: Mary Dangel, Frank Hooper, and Mary Parker. It was quitea thriving mining camp and was quite a sizeable school. Unquote. The Quartz Valley School is still functioning and is one of the few remaining rural schools in the county. It now employs two teachers (1960) and has the reputation of being a very fine school. Mrs. Rose Burton, Rose Marlahan Burton, has been the principal for many years,

Fort Jones School 1862.

As far as I can ascertain, the first school here in Fort Jones was held in a building which was located on the south corner of Main and Sterling Streets and was built over a little creek which flows past that area, seasonally, In the early days of the town, the Sterling Hotel was located where the firehall is now. Bill Mathews told me that the day the Sterling Hotel burned, the school was torn down to try to keep the fire from spreading to other buildings. The Episcopal Church which was erected in 1893 was built where the Sterling Hotel had been. After a few years the Church closed its doors, Later the town of Fort Jones purchased the property and used it for a Town Hall and Library. In the basement the town firetruck was kept and facilities installed for a jail. Eventually the Library and other offices were moved the building on the flat and the old Church dismantled and a new firehall was built.

My father, Ed Jordan, told me fifty or more years ago, that he went to school in a building that was just north of the Henry Piscantor home. That home is now owned by Tom Gardner, or at least that is where he lives. Dad told me the teacher at that time was Mr. I. A. Reynolds, (To be continued.)

KLAMATH ANCIEN TS TEARING UP COYDTE TRAPS TO PROTECT THE SPIRITS OF THE DEAD, an article from The Siskiyou News of November 27, 1924.

A superstition among Klamath Indians that when an Indian dies the spirit is transmitted to a coyote, is proving to be an obstacle to the trapping and poisoning operations of government trappers for the United States Biological Survey, recently asserted Stanley G. Jewett of Portland, in charge of predatory animal control in Oregon.

"Indians have been destroying traps, stealing poison meat and filching the dead coyotes this summer and fall,"
Mr. Jewett said. "We were at a loss to understand why till one old red skinned patriarch explained the situation to Mike Galarneau, government trapper in the Big Marsh region, on the reservation.

"The old Indian said: 'Me know coyotes kill sheep, chickens. Me know he hard on farmer. But when white man kill coyote, he kill spirit of my brother, he kill my father, my daughter. We Indians no like it.

"It is a throw back from the old tribal superstitions and no explanation to the Indians can convince them of the fallacy of their belief.

"This superstition explains, more than any other one factor, why there are more coyotes concentrated on the northern part of the Indian reservation than any other section in Klamath.

"Government Trapper Sawyer, who has been operating on the reservation, has had much of his equipment destroyed or stolen. G alarneau also has been unlucky in this respect.

"I understand that the superstition is only prevalent among the older members of the tribe."

The New Marriage Act.

The following is a copy of the Act passed by the last Legislature, amendatory of the Act concerning marriages, which takes effect on and after the 26th inst:

SECTION 1. Section seven of said Act shall be amended so as to read : Sec. 7. No person shall be joined in marriage. unless such person shall have first obtained a license, there for from the Clerk of the County Court of the county where such marriage is to take place, which licenses shall authorize any Judge. Justice of the Peace, clergyman or preacher of the Gospel, to celebrate and certify such marriage : but no such license shall be granted for the marriage of any male under 21 years of age, or for any female under the age of 18 years, without the consent of his or her father, or, if he be dead or incapable, of his or her mother or guardian, to be in such licenses, or unless the party or parties under the said ages, respectively, shall have been previously married: and , if any Clerk shall issue a license for the marriage of such minor, without, consent as aforesaid, he shall forfeit and pay a sum of not less than \$ 100, nor more then \$ 1,000, to the use of such father, mother or guardian, to be sued for and recovered in any Court having cognizance thereof; and for the purpose of ascertaining the age of the parties, such Clerk is hereby authorized to examine either party, or other witnesses, on oath, and the Clerk shall be entitled to receive for such certificate the sum of \$2.

Sec. 2. Section eight shall be amended so as to read: Section eight. Any Judge, Justice of the Peace, clergyman or preacher of the Gospel, who shall celebrate any marraige, shall make a certificate of such marriage, and file the same. togather with the license therefor, within thirty days thereafter, in the office of the County Recorder in and for the Cou nty in which said marriage was celebrated, and any person neg. lecting or refusing to make such return within the above requ uired time, shall forfeit for each and every such offense a sum of not exceeding \$ 50, to be paid into the Common School Fund of said county; and if any Judge, Justice of the Peace, clergyman or preacher of the Gospel, shall soleumize and join in marriage any couple without a license as aforesaid, (He) shall for every such offense forefeit and pay a sum not exceeding \$ 500, to be recovered on indictment, and to be into the Common School Fund of the county.

Sec. 3. Section nine shall be amended so as to read: Section 9. The Recorder shall record all such certificates of marriage, togather with the license, in a book to be kept for that purpose, within one month after receiving the same, and he shall be allowed to receive for such record, to include both certificate and license, the sum of \$ 1.

Sec.4. All laws or parts of laws heretofore enacted, in conflict with the provisions of this Act, are hereby repealed

OLIVER GENEALOGY

LAUNCELOT OLIVER, a Scotch Presbyterian from the north of Ireland, Antrim Co., where the Scotch had formed a colony, with his wife, Mary Walker, whom he married before coming to America, lived in Worcester, Mass.; then in Barre, Worcester Co., Mass., where Launcelot died, June 21, 1781 in the 78th year of his age.

His grave is found in the deserted Caldwell Cemetery in Darre, and his will in the Worcester County Registry of Probate. He was born in 1704; died June 24, 1781 at Barre, Worcester Co., Mass. Just when he came to America, or where he first settled, can but be conjectured from certain records. He joined the church in Darre on a letter from the church at Georgetown dated May 24, 1741 (this was doubtless Georgetown, Maine, then a province of Massachussetts), where many Scotch-Irash Presbyterians were gathered under the pastorate of Rev. Wm. McClanathan. Records show that he had a son baptized in Boston in October of 1741; and that in 1748 he was living in Worcester; and in 1749 that he payed one thousand and twenty-six (1026) pounds for a tract of one hundred and thirtythree (133) acres in the northwest quarter of the town of Rutland. This part was afterwards made into the town of Barre, and there he lived until his death, The church records show several items which bear upon his life, and mark him as a man of strong convictions. Launcelot's name is spelled various ways in the early records. On his tombstone it is spelled "Lanslet." He settled in Barre, Mass., where he died the 21st of June, 1781 -- Tombstone inscription.
